

SALES REGULATION | CHESTER BOOTS SALES

JANUARY 2026

CHESTER boots, a brand owned by CHB – CHESTERBOOTS, LDA., headquartered at Rua Dominguez Alvarez nº 44 – 4.9, 4150-801 Porto, Portugal, corporate taxpayer number 516 310 020, hereby promotes the campaign CHESTER boots Sales – January 2026, which is governed by the present regulation.

1. The purpose of this regulation is to define the conditions applicable to the promotional campaign CHESTER boots Sales – January 2026, carried out exclusively on the brand's official online store at www.chesterboots.pt.
2. The sales will take place from January 19th, 2026 to January 31st, 2026.
3. The sales are available to customers of CHESTER boots website in the countries where the brand ships: Portugal (mainland and islands), Spain (mainland and Balearic Islands), the Netherlands, France (mainland), Belgium, Luxembourg, Italy (mainland), Switzerland, Poland, Denmark, Finland, Estonia, Norway, Lithuania, and Hungary.
4. During the sales period, the following conditions apply:
 - a. 15% direct discount on:
 - i. Ankle boots
 - ii. Outdoor footwear
 - iii. Accessories
 - b. Free shipping on orders with a total value equal to or greater than €100, applicable only to items included in the sales campaign.

Discounts and offers are applied automatically at checkout and are only valid during the campaign period.

- a. This campaign cannot be combined with other promotions, discounts or promotional codes.
- b. Adding products to the cart does not guarantee stock reservation. Orders are only considered valid after completion of checkout and payment confirmation.
- c. All products are subject to existing stock availability. CHESTER boots reserves the right to refuse or cancel orders for products that are no longer available, with a full refund issued in such cases.

6. Stock Availability

- a. The website has limited stock of ankle boots, outdoor footwear and accessories.
- b. In the event that an item becomes unavailable after order confirmation, the customer will be informed and the amount paid will be fully refunded.
- c. Certain products may have longer shipping times, which will be clearly indicated at the time of purchase.

7. Estimated delivery times and shipping costs (when applicable) are detailed in the Terms and Conditions available at www.chesterboots.pt.

8. Returns and Exchanges

- a. If the ordered item does not fit, the customer has 14 days to return it, in accordance with the brand's return policy.
- b. Size exchanges are only accepted for items that are in stock.
